CHIEF'S NOTES

It was a proud day for the Burbank, Glendale, and Pasadena Fire Departments on January 13, when 24 firefighter recruits graduated from Class One of the Verdugo Fire Recruit Academy. This joint training academy took the best practices of three fire departments and instilled them in minds and

bodies eager to adopt the ways of the fire service. Six of these recruits are Glendale's newest probationary firefighters, and I know everyone will do all they can to encourage, support, and continue training these individuals. A warm welcome to the Fire Family to

Another proud day is coming up tomorrow, when we promote two long standing members of our department to the rank of Deputy Fire Chief. Steve Howard will be Deputy Chief of Operations, and Harold Scoggins will be Deputy Chief of Administration. We will also be promoting two new Fire Captains (Engineer Mike Bell and Engineer Ed Foster) and two Engineers (Firefighter John Shanley and Firefighter Juan Perez), and celebrating the appointment of Dave Woods as Fire Marshal, Mike Matlock as Public Safety Business Administrator, and Lenia Scanlon as Senior Administrative Analyst.

Today we received word that the automatic fire sprinkler system installation is complete at City Hall and is fully operational. It's an unobtrusive installation, an excellent example of a retrofit installation without interruption of business while maintaining the aesthetics of the building. Our thanks to Pat Shea from Public Works, along with Jeff Halpert and Tara Weintraub from the GFD, who worked with the contractor on this project and did an excellent job.

January 26 was the second anniversary of the Metrolink disaster that killed 11 and injured nearly 200 others. This tragedy was the "Big One" that many of us have been preparing for our entire career. This was a Special Ops incident, with Fire, EMS, USAR and HZMT from multiple agencies all involved, in addition to being a huge crime scene. Our success was measured in minutes by how quickly we effected rescue, triage, and transport for over 200 passengers, and it came together in 80 minutes or less while

the world was watching. Fortunately, we had fewer than 40 critical patients sent to 15 area hospitals, and the combined GFD/LAFD/hospital effort resulted in no additional fatalities. There were a lot of challenges along the way, but all involved public safety personnel carried it out with "Grit and Grace." The human side of the losses became more difficult with victims Scott McKeown, Liz Hill, and Julie Bennett, who all had special ties to us. The lack of a passenger manifest and missing persons list was another challenge. Fortunately we were able to account for everyone, literally leaving nothing unturned on this difficult accident site before relinquishing the scene at the 24 hour mark to the criminal investigation team.

Congratulations on 25 years of service with the Glendale Fire Department to Capt. Mark Berg, FF Chuck Manente, Engr. John McGaffin, Engr. Bob Launius, FF Joe Lopez, Capt. Ron Stanick, and Engr. Bryan Williams, and to Mike Matlock on 10 years with the GFD. We are grateful for all the time, effort and training you have invested to improve and sustain public safety for the Glendale community.

Last week was the kickoff for this year's Glendale Fire Wellness Program administered through Santa Ana College, and I'm pleased to announce that non-sworn personnel and spouses of all department members were invited to participate this year (with a nominal fee for spouses). We are delighted with the enthusiastic response to this program and look forward to the increased participation this year.

Our day in and day out efforts to help people took a somewhat different turn a week ago during a near-record cold spell, with large numbers of calls related to broken pipes and flooding due to freezing temperatures. A number of grateful citizens have contacted me to express their appreciation for the assistance they received, including the following:

Dear Chief Gray,

On Sunday, January 24, the news reported that a number of emergency calls were being answered within the Southern California area due to the extreme weather conditions, which caused various pipes to burst. Little did I know, at the time, that our church was also experiencing problems. Evidently, three fire sprinklers on top of the front roof's overhang burst and set off the fire alarm. A helpful neighbor called in to your station.

On Monday, January 15, a message was waiting for me from Steve Parrish, who explained that they replaced three sprinklers and also drained and refilled the specific water supply for this church property. He also gave us further suggestions regarding the replacement of these sprinklers. This has already been accomplished. Also, we are very grateful that even though several members of your crew entered the church premises, they did not let our church cat outdoors and great care was taken so that the interior was left clean and in order.

Steve informed me that your station received numerous calls that day and, therefore, responded later that evening. I requested the information regarding the individuals who were involved so that we could express our appreciation. Our deepest gratitude and heartfelt thanks to the magnificent crews of Engine 25, Engine 23, and Truck 26 on the "A" shift. Please convey our sincere appreciation for their outstanding performance and for the peace of mind in knowing that we can always count on the Glendale Fire Department. I pray that more individuals remember to thank you, for your great leadership, and for your dedicated crewmembers.

Support Captain's Update

The above ground storage tank project is nearing completion and within a couple of months depending on Information Services, the computer links will be up and running allowing us to capture valuable information on vehicles and apparatus for maintenance purposes. We are currently on line to monitor fuel levels at six of the nine stations with 23, 24, 27 still off line. Fuel tank levels are monitored once a day by the Shop to automate the reordering of fuel. Once the complete system is on line we will have training and distribute new chip keys.



The Opticom Preemption System to control signals in the downtown area is scheduled to be installed in approximately one month and should take approximately one month to complete. All front line apparatus will have transmitters installed. Once complete, we will have training on which signals are controlled and how the system works.

We have finally outfitted our Strike Team Leader truck with radios and lights and will be adding additional equipment to enhance strike team capabilities and safety. This is the red GMC crew cab housed at Station 21. We are still waiting on our latest Yukon command vehicle which is being outfitted and is scheduled to be here by the end of February.

We have just completed Mechanic 1 interviews to upgrade a position in the Shop and started the background process, and yes, we are again starting interviews to fill the storeroom position. We are also auctioning off the last of our classic Chevy Caprices and redistributing some of the Crown Vics.

Last but not least, hopefully some of you have noticed the new audio video system in the Community Room which will greatly enhance our training and presentations. – *Gerry Miller, Support Captain*

Hello everyone,

I am sure you're all aware by now that I'm back and in the EMS office as the Paramedic Coordinator. This is an exciting time, as there are new things happening in EMS. I am happy to be in EMS and even more excited to be involved in the upcoming changes. Remember you're always welcome to stop by the EMS office anytime you like or you can contact me at 548-4812.

Here is an example of those new things in EMS: Most of you are aware that RA22 will be going into service soon. There are lot of aspects to placing an RA into service, and most if not all those things are in motion as I write this article. Examples of the issues:

1) RA is being serviced,

- 2) RA is being re-numbered to RA22,
- 3) Equipment is ordered and being shipped,
- 4) Murphy will outfit new rig with equipment,

5) Breathing apparatus are ordered and being shipped,

6) Computer and scanner are ordered and being shipped,

7) New gurney and stair chair are out to bid,

8) Modifications to dorms at 22, P.O. has been issued, and

9) DHS notification and inspection of new RA is pending. The rotation for the new RA22 has been determined and will be a five-seat rotation. The exact number of shifts in each position is still to be determined. But here is an example using the number 3 (since we work three shifts in a cycle): Paramedic #1 would work three shifts as patient person on RA22, three shifts as radio person on RA22, three shifts on Engine 22, three shifts as patient person on RA29, three shifts as radio person on RA29, then the whole cycle starts over again. Again, the number of shifts in each position is still to be determined.

We have purchased seven new Zoll defibrillators and will be conducting training on the new units during the next couple of weeks.

During 2007, we are going to be looking at the possibility of adding a BLS component to our EMS delivery system. We are also going to continue to work on increasing the number of paramedics in our system, and we will be looking at updating and replacing some of our older equipment.

Again, it's good to be back. Keep your eyes open for more new things from EMS.

2006 ACCOMPLISHMENTS

ARSON UNIT - 2006 ACCOMPLISHMENTS

The year started out with the intentionally set fire of the city Christmas tree at Perkins Square. The suspect, Bruce Morrison, was arrested and admitted to lighting the fire. He was upset over the number of parking tickets he had received, and he had received another parking ticket prior to lighting the fire. Morrison pled out to three years' felony probation, arson registrant, and restitution to the city.

The fatal fire that occurred at 251 Wonderview went to trial in Pasadena. Arson Investigator Mike Richardson testified to the origin and cause. Andranik Khajarian was found guilty of second-degree murder and was sentenced to 25 years to life.

An intentionally set fire occurred at 1320 South Central. The suspect, Shaun Tate, broke into the music store at this address and set the fire to conceal a burglary. He admitted to lighting the fire. He pled to three years in a lock-down mental facility and arson registrant.

In November 2005, suspect Nataliya Fataliyeva lit a fire at 311 North Howard. Fataliyeva held a handheld propane lighter to the Plexiglas window of her boyfriend's window, which caused the fire to spread into the interior of the occupancy. In 2006, several attempts of legal maneuvering by her attorney to get the case dismissed caused multiple court dates which finally led to the preliminary hearing that resulted in Fataliyeva to be held for trial. Fataliyeva pled to two years in State prison and arson registrant.

Yuri Vladimir Sanchez had an argument with his girl-

friend at 115 West Eulalia. It is alleged that Sanchez lit her clothes on fire. A felony was filed against Sanchez, case pending.

Ragarding the Metrolink case, the defense team for Manuel Alvarez was removed from the case and a new defense team was appointed. The defense team examined the affected train cars. An 11-count murder case is still active, pending trial. The Federal Railroad Administration also examined the trains at a later date in order to assist in providing safety measures for future travel via train.

On July 4, the Arson Unit patrolled the city for illegal fireworks activity. The Unit consisted of Investigators Mike Richardson and Miguel Porras, who patrolled in a undercover vehicle. Engr. John Miller rode with a police officer in a black and white. One citation was issued by Officer Porras. Illegal firework activity was minimal and the amount of confiscated illegal fireworks was also low. The confiscated fireworks were transported July 25 to the Montebello Fire Department for disposal.

Vaginak Atikyan is believed to be responsible for intentionally setting fire to his vehicle, a BMW-X5, at 511 Justin. This occurred on August 28, 2006. The following day, we executed a search warrant at his home in Pasadena and at the Justin address to gather evidence related to the crime. He was not home and has been avoiding contacting the Arson Unit. His fingerprint was obtained from the charcoal lighter fluid used to light the fire. The felony was filed against him and an arrest warrant was issued. After several attempts of surveillance at his home, Porras and Richardson observed him driving away in his vehicle. They pulled him over and arrested him for the arson. Glendale Police transported him to the Glendale jail. He made a spontaneous statement when he was told he was arrested for arson, stating all we had was a case of vandalism. Vaginak bonded out of jail and his preliminary hearing is set for late this month.

Arson Unit personnel testified at the preliminary hearing for Tony Yarijanian, the suspect responsible for the arson to Safari Tan. He was held to answer and the trial should start sometime next month. His defense attorney made several attempts to have the case dismissed, which resulted in several court days throughout 2006. Yarijanian has since hired a Mark Geragos as his new attorney

Testimony was also provided in Pasadena Superior Court on a case involving suspect Adam Siefke, who intentionally set fire to his apartment in Pasadena. Siefke was found guilty and received five years in state prison.

On November 7, the arson unit responded to 3912

Markridge at approximately 12 a.m. regarding a fire in the street. Engr. Jeff Giampaolo requested our response. A male who lives at the location set fire to a pair of shoes using gasoline. The suspect placed the shoes in the middle of the street, where white spray paint denoted an Aryan Power symbol. The suspect tossed the gasoline container he used to accelerate the fire down the street when the fumes came in contact with the burning shoes. The fire spread to the curb line, burning debris that had collected along the curb. Based on prior contact the Glendale Police had had with the suspect and the crime that had just occurred, it was determined to write a search warrant for the location. The warrant was issued and executed. The suspect, Gary Morey, admitted to lighting the fire and handed over the disposable lighter used to ignite the fire, along with the clothing he wore while perpetrating the act. A felony was filed and the case is pending.

There were five juvenile cases that went to the Pasadena DA's office or were too young to prosecute. All of the cases that went to Pasadena resulted in probation and a counseling program. Juvenile arrests were down in 2006 compared to 2005. The number of suspicious fires remained high in 2006, but most of these fires did not meet the rigid Department of Justice guidelines that define a recordable arson.

Other activities throughout the year:

• Assisted in the background checks for firefighter recruits and cadets.

• Made presentations at the Kiwanis Club and the Chamber of Commerce.

• Taught a class on fire investigation to the Tri-City Firefighter Recruit class.

• Attended a one-week class on ACAMS taught by Operation Archangel.

• Attended a one-day class on Improvised Explosive Devices.

• Attended a three-day class on juvenile firesetters.

• Assisted with numerous search warrants with the Glendale Police Burglary/Auto Theft/Arson Unit.

• Worked on the Platoon Investigation Program.

ARSON UNIT - 2007 GOALS

• Continue to work cohesively with the Glendale Police Department.

• Continue to pursue and finalize the Platoon Investigator Program with Capt. Eric Indermill and Fire Marshal Dave Woods. Inspire the present investigators and new investigator(s) selected.

• Provide training to the Platoon Investigators.

• Prepare for the Metrolink case and future arson cases.

• Gain more knowledge and expertise through education.

FIRE ENGINEERING UNIT - 2007 GOALS

The Fire Engineering Unit is currently assigned the following responsibilities:

1. Review/approve building and fire plans

2. *Staff the Fire Counter at the Permit Services Center* 3. *Provide post-incident analysis as needed*

4. Serve as the GFD liaison on the City Hall campus

5. Administer the Vegetation Management Program

In an attempt to keep the Fire Engineering Unit functioning efficiently, we have identified some goals for 2007 regarding our operations. We appreciate your support as we strive to maintain a high level of service and quality.

Fire Engineering Counter (Permit Services Center)

In an attempt to exemplify the GFD motto, "We Help People," our goal is to respond promptly and courteously when called to assist a customer at the counter.

• The counter will be staffed in full, half-day and lunchhour shifts (MWF 0700-1530 and TTH 1200-1600), mimicking the hours observed by Building and Safety.

• Staff will allocate 15 minutes per customer/project; extended assistance will be provided at the discretion of staff.

• Staff will maintain a log to document all activities at the counter.

Staffing

Currently the FE Unit has three staff members on a 9/80 schedule, two with alternate, opposite Mondays off and the third with alternate Fridays off (B track).

• We will be hiring one additional FPEA who should be on staff by mid-February

• In order to accommodate the additional staff, the Building Official has indicated office space will be available in the Permit Services Center for the FPC.

• Establish office for FPC at FPEMC and PSC.

Plan reviews

Plan review remains a keystone of our operations. The FPC is charged with managing the plan review process.

• Submitted plans for major projects will be assigned to a specific staff member (or team); routine plans will

be reviewed based on date submitted.

- Review Building and Fire plans as submitted
- Review Planning/Zoning entitlements as submitted

• Review GRA, GWP and GPW projects as submitted

• The Project Tracking List (FileMaker Pro) will be maintained for submitted building and fire plans to track plan status, dates submitted, reviewed and approved, along with assigned staff and hours spent on the project

• The time spent reviewing each plan will be documented using project worksheets

• Goal – 2 week turn-around for routine submitted plans; 4 weeks for major projects

• Assist Building & Safety as the utilization of the new Permit Services Technicians is clarified regarding permit issuance and plan review for meeting minimum submittal requirements

• Implement Industrial Waste plan review utilizing FOG Guidelines to be provided by EMC Demirjian.

• Coordinate with GWP to provide static pressure data to sprinkler contractors

Vegetation Management

Selected FPB staff assist with management of the VMP.

• Objective - review of landscape plans to be completed by all Fire Engineering staff members

• Objective – continue with plant identification and landscape training for all FPB inspectors to assist with landscape inspections

• Objective – provide department wide training for identification of hazardous vegetation and VMP inspections

• Provide VMP training to VMP Fire Companies

• Coordinate abatement of hazards on city parcels (GYA, LACo, goats, etc.)

• Manage contract with LACo for vacant lot hazard abatement; process City Council reports for public hearings as required

• Administer annual VMP inspections

• Administer the FireWise Program as needed

HUMAN RESOURCES & COMMUNITY SERVICES



It is also a goal of ours to implement Emergency Preparedness into the 2007 Jr. Fire Program, and with our new Jr. Fire manuals hot off the press, we are on our way of achieving this goal. OPERATIONS

On Tuesday, December 26, at 11:27 p.m., Engine 24B was dispatched to a fire alarm in the 1000 block of Cortez Drive. Engine 24 found a large, two-story, single-family dwelling with smoke and fire visible from attic vents near the chimney. Informants met firefighters in the street and stated that the people were still inside. Three occupants were found inside the home, in a second story bedroom. All occupants were evacuated. Smoke on the interior was not visible at this time. The fire was contained to the attic and the cause was determined to be a broken chimney. The fire was extinguished and overhauled, with structural damage estimated at \$100,000 and contents at \$25,000. Units responding were Battalion 2, Rescue Ambulance 26, Engines 24, 25 & 26, and Trucks 21 & 29.

Earlier the same evening, at 6:38 p.m., Truck 21 and Battalion 2 responded to assist units on scene of a second-alarm structure fire in the city of Burbank. Upon arrival, Battalion 2 was assigned Division "A", the front side of the fully involved commercial structure located at 4411 Magnolia. The Incident Commander was Battalion Chief Robert Trowbridge of the Burbank Fire Department. Several master stream appliances were used to control the fire prior to sending firefighters to the interior with hand lines. There were no injuries to civilians or firefighters. Damage to the structure was estimated to be in excess of \$300,000, with the contents estimated at over \$100,000 loss. The cause of the fire is still under investigation.

CORRESPONDENCE

Dear Fire Chief Gray:

The Glendale Fire Department must be the best Fire Department in the world. On Tuesday night, December 26, 2006, our house had an attic fire. Our fire alarm went off at 11:22 p.m. and alerted the Fire Department. Also, two girls who were walking on Cortez Drive saw smoke bellowing from the attic vent and flames on the roof near the fireplace chimney. These alert girls got a neighbor, Warren McCourtney, to call 911 to report a fire. This additional information alerted the Fire Department to dispatch more equipment.

My wife and I were in bed just below the attic fire. However, we did not know anything was wrong. When the fire alarm went off, we thought it was a false alarm. We heard sirens coming near our area and wondered where they were going, and Boom – they were at our house on both sides – on Cortez Drive and the alley. They must have arrived at our house within 3 or 4 minutes after the alarm went off.

The firemen all hit the deck running, and all knew exactly what their duties were. The new large fire truck with a high-rise ladder extended from Cortez Drive up a little hill, over our three-story home, and delivered water directly on the fire area. One crew went to the building roof from the alley side to cut an opening in the roof for better access to the attic fire. Another crew brought a water line in the house up the stairs and through the access opening to the attic and put water directly on the fire area and the smoldering rafters.

We, of course, had to leave the house and watched this activity with amazement. They all knew what to do and worked together like clockwork.

The fire was put out in about 15 minutes or so, and the crews worked for two more hours to make sure all the smoldering rafters were completely extinguished. They also had placed tarps over the furniture in two rooms to minimize possible water damage. Then, after all watering had stopped, they had a big vacuum equipment



that sucked out as much excess water as they could.

The next day, they came back and removed all the tarps and completed basic cleanup of all the rooms involved.

Captain Mark Berg and his entire group of excellent firefighters should be complimented for their wonderful action. We want to thank them from the bottom of our hearts for saving our home and possibly saving our lives.

EMS PROGRAM REVIEW

On December 7, the Emergency Medical Services (EMS) Agency of Los Angeles County conducted its annual site visit to review compliance with the EMT-Paramedic Service Provider Agreement, Quality Improvement Policy and the Supply and Resupply of Designated ASLS Units/Vehicles policy relating to controlled drugs carried on ALS units. They found no action items requiring changes or follow-up in our conduct of the program.

PREPARATIONS FOR FIFTH RA

Work continues to prepare Station 22 to house the newest Rescue Ambulance and its Firefighter/Paramedics. Work includes adding employee lockers and partitions in sleeping areas, as well as adding necessary computer and scanning capacity for Patient Contact Report processing. Other work is taking place to acquire gurneys, stair chairs, breathing apparatus, and radios. We have a March 1 target date for implementation.

NEW DEFIBRILLATORS

As a part of Measure B, Los Angeles County is funding the purchase of 12-lead EKG equipment by paramedic providers. They will reimburse our purchase of seven defibrillators at an amount not to exceed \$17,000 per unit (\$119,000). The defibrillators have been received and will be put into service as soon as training is completed.

EMS CUSTOMER SERVICE SURVEY

In the fall of each year, we conduct a survey of our patients by mailing a questionnaire to all who received paramedic service during November or December. We have received the results and are happy to be able to say that our patients are still very pleased with the quality of the service they receive – from the dispatchers to the paramedics. Where problems were identified, we are following up with the patients to see what we might have done better.

TRAFFIC SIGNAL PREEMPTION

The traffic signal emergency vehicle preemption system is scheduled to start installation in approximately one month and, with no unforeseen problems, will be completed in approximately 30 days. We have also identified the 20 emergency vehicles to have transmitters installed and are hoping to have them done during that same time.

UNDERGOUND STORAGE TANKS

The underground storage tank project is 95% complete. All tanks and or plumbing have been changed out and all stations are pumping fuel. The last phase is for Information Services to make the connections for the system to go on line so that we can capture vehicle fueling information and improve security.


