NOTICE OF SLURRY SEAL CONSTRUCTION

FISCAL YEAR 2013-14 SLURRY SEAL AND PAVEMENT REPAIR PROGRAM

Dear Resident and Property/Business Owner:

The City of Glendale's Public Works Department has retained our company to make certain street improvements in your neighborhood as part of the <u>Fiscal Year 2013-14 Slurry Seal and Pavement Repair Program</u>. The duration of the entire project is approximately 80 working days. The construction is scheduled to start on July 7, 2014 and is expected to be completed by the end of October 2014, barring unforeseen circumstances or adverse weather conditions.

The scope of work includes the following:

Slurry Seal

- Selective removal and replacement of Portland cement concrete pavement;
- Selective removal/reconstruction/grinding of deteriorated pavement and placement of asphalt concrete pavement;
- Application of crack sealing material;
- Application of emulsion aggregate slurry (Slurry Seal Type II) or application of emulsion aggregate slurry over the asphalt rubber aggregate membrane (ARAM);
- Selective removal and repair of broken and damaged sidewalk; curb; curb and gutter; cross gutter, and alley apron;
- Construction of new curb ramps;
- Adjustment of existing manholes and water meters to finished grade; and,
- Removal and replacement of existing traffic striping and pavement marking.

Sparr Boulevard Improvements

• In addition to above described work, intersections of Montecito Drive, Menlo Drive, Bagdad Place, El Arbolita Drive, Harmon Place, and Vickers Drive with Sparr Boulevard will be modified to enhance the safety and accessibility for the pedestrians.

Our company is committed to working with you to help alleviate the impact of the construction on your daily activities. Every effort will be made to minimize any inconveniences to you. If you need to drive through the construction zone, please allow additional commuting time.

We are responsible for sequencing and scheduling the work. We will post a door hanger three (3) days prior to the start of construction. The door hanger will specify the exact date and time when the work will take place on your street. We will also post "NO PARKING" signs in the work zone 30 hours in advance of working on your street.

Slurry seal is a wet liquid asphalt mixture. To ensure an acceptable slurry seal quality (1), it is important that no vehicles travel or pedestrians walk on the newly laid slurry seal until 4:30 P.M. Driving on it will damage the slurry seal and your car. On the day of slurry seal application, please refrain from using water that may run onto the street surface. If possible, please turn off the sprinklers during the construction activity on your street. If slurry seal application occurs on a trash collection day on your street, trash will be picked up as scheduled.

(1) For clarification, slurry sealing prolongs the service life and restores the appearance of the pavement and prevent further deterioration of the pavement to a point when the street will need resurfacing or reconstruction. Prior to the slurry application, cracks are sealed to minimize reflective cracking. On some streets, reflective cracking may occur due to thermal expansion and contraction. These hairline cracks do not affect the performance of the newly laid slurry seal.

Unfortunately, construction is sometimes delayed in which case, the previous day's work may not be finished and construction activities will resume the next working day or will be rescheduled. Thank you for your patience while we work to improve the City of Glendale.


