ADMINISTRATIVE EXCEPTION CASE NO. PAE1316538**

Dear Mr. Silva:

Pursuant to the provisions of the Glendale Municipal Code, Chapter 30.44.020 (E), the Community Development Department has processed your application for an Administrative Exception to allow an existing garage to be maintained with an interior clear depth of four percent less than what is required for an existing two-car covered and enclosed garage in conjunction with a 428 square foot addition at the rear of the existing house, as required by Chapter 30.32.050 of the Glendale Municipal Code. The subject property is located at **908 Coronado Drive**, in the "R1" - Low Density Residential Zone, Floor Area Ratio District I and described as Lot 16 and Portion of Lot 15, Rossmoyne Tract, in the City of Glendale, County of Los Angeles.

ENVIRONMENTAL RECOMMENDATION: This project is exempt from environmental review as a Class 1 "Existing Facility" exemption (Section 15301 (e) (1) of the State CEQA Guidelines).

REQUIRED/MANDATED FINDINGS

After considering the evidence presented with respect to this application, the plans submitted therewith, the Planning Hearing Officer has **GRANTED WITH CONDITIONS**, your application based on the following findings:

- A. The granting of the exception will result in design improvements, or there are space restrictions on the site that preclude full compliance with the Code requirements without hardship.**

The subject property is an 8,090 square-foot lot developed in 1926 with a modest 1,406 square-foot, one-story single-family residence and a detached 324 square-foot single-car garage. The house is separated from the garage by 20 feet 11 inches. The house is centrally located on the lot, while the garage is situated behind the house. The proposed project will result in 428 square feet of additional floor area to

the existing single-family residence. The addition will not increase the number of bedrooms; it will only result in a relocation of one of the bedrooms and a conversion of the existing bedroom into a den at the rear of the building.

The Zoning Code requires that a one-car garage be expanded to meet the minimum parking requirement upon any addition to the existing residence. The applicant is requesting to maintain the existing garage which is four percent less than the minimum depth required to qualify as a two-car garage. The existing garage has an interior width of 17 feet two inches and a depth of 17 feet three inches where 16 feet wide by 18 feet deep is required by the Zoning Code.

There are space restrictions on the site which prevent the expansion of the existing garage complying with the Zoning Code. The existing house, patio and oak trees located just over the neighboring property line behind the existing garage would greatly impact the expansion of the existing garage or location of a new garage. Additionally, the garage could not expand closer to the house and patio cover without eliminating the required driveway turning radius. Therefore, the existing garage cannot be easily modified without substantially changing the existing site conditions and to deny the addition would unduly restrict the flexibility for reasonable use and improvement of the property.

B. The granting of the exception will not be materially detrimental to the public welfare or injurious to the property or improvements in such zone or neighborhood in which the property is located.

This proposed expansion will be located at the rear of the residence. The purpose of the addition is to make the house more functional, creating a master bedroom and bathroom and converting the existing bedroom into a TV/sitting room. The proposed addition would not create additional bedrooms and would not intensify parking demand, and as such, will not be detrimental to the public welfare, injurious to the property, or improvements in the zone. The addition will not be visible from the street and will still allow for adequate open space, light, and ventilation for the subject residence as well as adjacent residences.

C. The granting of the exception will not be contrary to the objectives of the applicable regulations.

The proposed addition meets all other Zoning Code requirements of the R1 Zoning Code standards, such as lot coverage, floor area ratio, landscaping, and setback distances. The purpose of the administrative exception procedure is to provide a simplified means for considering applications for minor deviations from Code standards. These standards have been developed to allow reasonable use of properties in order to promote the public health, safety, and general welfare. The proposed 428 square-foot addition will allow reasonable development of the site that meets all other Zoning regulations and the existing 17 foot, two inch by 17 foot three inch garage still serves the single family residence. Therefore, granting the four percent exception of less than the minimum garage depth will not be contrary to the objectives of the applicable regulations.

CONDITIONS OF APPROVAL

APPROVAL of this Administrative Exception shall be subject to the following conditions:

1. That the development shall be in substantial accord with the plans submitted with the application except for any modifications as may be required to meet specific Code standards or other conditions stipulated herein to the satisfaction of the Hearing Officer.
2. That all necessary permits shall be obtained from the Building and Safety Division and all construction shall be in compliance with the Glendale Building Code and all other applicable regulations.
3. That design review approval or exemption shall be obtained prior to the issuance of a building permit.
4. That any expansion or modification of the dwelling which is different than what is represented as part of this Administrative Exception application, shall require a new application as determined by the Hearing Officer.
5. That the garage door width be widened to 16 feet by seven feet and the driveway approach to the new garage door be widened to accommodate vehicle access.

APPEAL PERIOD, TIME LIMITS, LAPSE OF PRIVILEGES, TIME EXTENSIONS

The applicant's attention is called to the fact that this grant is not a permit or license and that any permits and licenses required by law must be obtained from the proper City and public agency.

Under the provisions of the Glendale Municipal Code, Title 30, Chapter 30.62, any person affected by the above decision has the right to appeal said decision to the Planning Commission if it is believed that the decision is in error or that procedural errors have occurred, or if there is substantial new evidence which could not have been reasonably presented.

It is strongly advised that appeals be filed early during the appeal period and in person so that imperfections/incompleteness may be corrected before the appeal period expires. Any appeal must be filed on the prescribed forms within **fifteen (15) days** following the actual date of the decision. Information regarding appeals and appeal forms will be provided by the Building and Safety Division upon request and must be filed with the prescribed fee **prior to expiration of the 15-day period, on or before August 15, 2013**, in the Building and Safety Division, 633 East Broadway, Room 101.

GMC CHAPTER 30.41 PROVIDES FOR

TERMINATION: Every right or privilege authorized by an Administrative Exception shall terminate two (2) years after the granting of such, unless the exercise of such right or

privilege has commenced in good faith prior to such time, except as otherwise provided for.

CESSATION: An Administrative Exception may be terminated by the review authority upon any interruption or cessation of the use permitted by the Administrative Exception for one year or more in the continuous exercise in good faith of such right and privilege.

EXTENSION: Permits granted by such right or privilege may be requested one time and extended for up to a maximum of one (1) additional year upon receipt of a written request from the applicant and demonstration that a reasonable effort to act on such right and privilege has commenced within the two (2) years of the approval date. In granting such extension the applicable review authority shall make a written finding that neighborhood conditions have not substantially changed since the granting of the administrative exception.

TRANSFERABILITY

This authorization runs with the land or the use for which it was intended for and approved. In the event the property is to be sold, leased, rented or occupied by any person or corporation other than yourself, it is incumbent that you advise them regarding the conditions and/or limitations of this grant.

VIOLATIONS OF THESE CONDITIONS

Violations of conditions required by this determination may constitute a misdemeanor or infraction under section 1.20.010 of the Glendale Municipal Code (GMC) and/or a violation of other local, State or Federal laws or regulations. Unless a specific penalty is provided, any person convicted of a misdemeanor shall be punished by a fine not to exceed one thousand dollars (\$1,000.00), or imprisonment for a term not to exceed six (6) months, or by both fine and imprisonment. Infractions are punishable by a fine not exceeding the sum of five hundred dollars (\$500.00) for each violation.

Violations of conditions required by this determination may be grounds for a revocation.

REVOCAION

Section 30.64.020 – Revocation – The Community Development Department shall have continuing jurisdiction over variances, conditional use permits and administrative exceptions. To consider the revocation, the Director of Community Development shall hold a public hearing after giving notice by the same procedure as for consideration of a variance at least 10 days notice by mail to the applicant or permittee.

NOTICE – subsequent contacts with this office

The Applicant is further advised that all subsequent contacts with this office regarding this determination must be with the Case Planner first and then, the Hearing Officer who acted on this case. This would include clarification, verification of condition compliance and plans or building permit applications, etc., and shall be accomplished **By Appointment Only**, in order to assure that you receive service with a minimum amount of waiting. You should advise any consultant representing you of this requirement as well.
