Conditions:

- 1. Revise the landscape plan at the rear of the property to have the landscaping against the building wall/windows and locate large tree away from the building to provide sufficient area for growth.
- 2. Provide bike racks and identify an accessible location on the plans.
- 3. Oak trees indicated on landscape plan are not appropriate to the style of the architecture. Provide an alternate tree species.
- 4. Tree boxes should be 6 inches taller than the tree box size but can step down where necessary to meet fire department requirements.

5. Masonite siding is not a durable material and is therefore not appropriate for this project. Provide an alternate material.

Considerations:

- 1. Consider providing more shading devices, similar to awnings shown on 5th floor units, and specifically on the tall vertical windows of the south elevation.
- 2. Consider providing more realistic stoop entries at the street level units along Elk Avenue to provide a more visually distinctive ground level character.

The Design Review Board approves the design of projects only. Approval of a project by the Design Review Board does not constitute an approval of compliance with the Zoning Code and/or Building Code requirements.
