RE: 3200 EAST GLENOAKS BOULEVARD WIRELESS TELECOMMUNICATION FACILITY APPLICATION PWTF 1410558

Dear Ms. Desmond:

Pursuant to the provisions of the Glendale Municipal Code, Chapter 30.48.020 for a wireless telecommunications facility permit, the Community Development Department has processed your application to establish a new unmanned wireless telecommunications facility for Verizon Wireless in the "SR" - (Special Recreation) Zone located at **3200 East Glenoaks Boulevard**, and described as Portion of Lot 89 of Watts Subdivision of a Part of Rancho San Rafael, in the City of Glendale, County of Los Angeles.

ENVIRONMENTAL DETERMINATION

This project is exempt from environmental review as a Class 3 "New Construction or Conversion of Small Structures" exemption (Section 15303 of the State CEQA Guidelines).

REQUIRED/MANDATED FINDINGS

After considering the evidence presented with respect to this application, the plans submitted therewith, the Planning Hearing Officer has **GRANTED WITH CONDITIONS** your application based on the following findings:

 To the maximum extent reasonably feasible, the proposed wireless telecommunications facility has been designed to achieve compatibility with the community.

As shown on the plans, the proposed installation consists of a total of eight panel antennas, eight PRUs with A2 and two Raycaps on two arrays concealed inside faux shrubbery screening treatment, and equipment cabinets, utility cabinets, and standby generator mounted inside a CMU wall enclosure.

The proposed antennas will be concealed within monoshrubs and will integrate with the existing nearby vegetation. The proposed CMU enclosure will be consistent with other existing nearby masonry enclosures. This is illustrated in the photo simulations.

2. Alternative configurations will not increase community compatibility or are not reasonably feasible.

The proposed antennas will be installed on the ground within monoshrubs at two different locations of the hillside to minimize the visual impact. An alternative would be to locate all antennas within a tree structure. However, in order to achieve the same coverage, the tree structure would have to be of substantial height and would more conspicuous than the proposed configuration.

3. Alternative locations on the site will not increase community compatibility or are not reasonably feasible.

Other locations at the proposed site are not reasonably feasible. The proposed antennas will be located on slopes with different orientations to satisfy coverage objectives. Also, the location of the equipment enclosure was selected with input from the Community Services and Parks Department for suitability and proximity to the proposed antennas.

4. The location of the wireless telecommunications facility on alternative sites will not increase community compatibility or is not reasonably feasible.

The hilltop location of the site offers no other viable alternatives to achieve the necessary coverage.

5. The facility is necessary to close a significant gap in coverage.

The radio frequency propagation maps submitted with the application show that the proposed facility is necessary to close a significant gap in coverage in the residential areas to the south and east of the facility. The Wireless Systems Administrator for the City's Information Services Department, reviewed the application materials and maps, and concurred that this site is necessary to fill a gap in coverage consistent with the ordinance for Wireless Telecommunications Facilities Permits.

 The applicant has submitted a statement of its willingness to allow other carriers to co-locate on the proposed wireless telecommunications facility wherever technically and economically feasible and where co-location would not harm community compatibility.

The applicant has submitted a statement of Verizon Wireless's willingness to allow other carriers to collocate on the site, wherever technically and economically feasible and compatible, as required in Section 30.40.020 (H) GMC.

7. Noise generated by equipment will not be unnecessary, excessive, annoying nor be detrimental to the public health, safety, and welfare.

No excessive noise will be generated by the proposed facility. The proposed equipment will not emit any noise decibels in excess of established noise standards contained in Chapter 8.36 of the Glendale Municipal Code.

8. The facility complies with all of the requirements of state and federal laws, regulations and orders.

The applicant provided satisfactory evidence that the existing and proposed facility will meet all Federal Communications Commission (FCC) requirements, state and federal laws, and local regulations and orders.

CONDITIONS OF APPROVAL

APPROVAL of this Wireless Telecommunication Facility (WTF) shall be subject to the following conditions:

- That the development shall be in substantial accord with the plans submitted with the application except for any modifications as may be required to meet specific Code standards or other conditions stipulated herein to the satisfaction of the Hearing Officer.
- 2. That all necessary permits (i.e., building, fire, engineering, etc.) shall be obtained from the Building and Safety Division and all construction shall be in compliance with the Glendale Building Code and all other applicable regulations.
- That all licenses, permits as required or approvals from Federal, State, or County or City authorities, including the City Clerk, shall be obtained and kept current at all times.
- 4. That the premises shall be made available and accessible to any authorized City personnel (Building, Fire, Police, Planning and Neighborhood Services, etc.) for inspection to ascertain that all conditions of approval are in compliance.

- That any transmissions shall not produce noise or other disturbances, which
 would interfere with normal activities in the area. The opinion of the Hearing
 Officer shall determine or settle disputes concerning this condition.
- 6. That any equipment service lighting shall be directed into the work area and shielded away from adjacent properties.
- 7. That the premises be maintained in a clean and orderly condition, free of weeds, trash and graffiti.
- 8. That the authorization granted herein shall be valid for a period of 10 years until **October 26, 2025**, until at which time, a reapplication must be made prior to the expiration date.

APPEAL PERIOD

The applicant's attention is called to the fact that this grant is not a permit or license and that any permits and licenses required by law must be obtained from the proper City and public agency.

APPEAL PERIOD

Under the provisions of the Glendale Municipal Code, Title 30, Chapter 30.62, any person affected by the above decision has the right to appeal said decision to the Planning Commission if it is believed that the decision is in error or that procedural errors have occurred, or if there is substantial new evidence which could not have been reasonably presented. It is strongly advised that appeals be filed early during the appeal period and in person so that imperfections/incompleteness may be corrected before the appeal period expires. Any appeal must be filed on the prescribed forms within fifteen (15) days following the actual date of the decision. Information regarding appeals and appeal forms will be provided by the Permit Services Center (PSC) or the Community Development Department (CDD) upon request and must be filed with the prescribed fee prior to expiration of the 15-day period, on or before **November 10, 2015**, at the Permit Services Center (PSC), 633 East Broadway, Room 101, Monday thru Friday 7:00 am to 12:00 pm, or at the Community Development Department (CDD), 633 East Broadway, Room 103, Monday thru Friday 12:00 pm to 5 pm.

TIME LIMITS (GMC Chapter 30.41)

Termination

Every right or privilege authorized by a Wireless Telecommunications Facility shall terminate two (2) years after the granting of such, unless the exercise of such right or privilege has commenced in good faith prior to such time, except as otherwise provided for.

Lapse of Privilege

A Wireless Telecommunications Facility may be terminated by the review authority upon any interruption or cessation of the use permitted by the Wireless Telecommunications Facility for one year or more in the continuous exercise in good faith of such right and privilege.

Time Extension

Permits granted by such right or privilege may be requested one time and extended for up to a maximum of one (1) additional year upon receipt of a written request from the applicant and demonstration that a reasonable effort to act on such right and privilege has commenced within the two (2) years of the approval date. In granting such extension the applicable review authority shall make a written finding that neighborhood conditions have not substantially changed since the granting of the administrative exception.

TRANSFERABILITY

This authorization runs with the land or the use for which it was intended for and approved. In the event the property is to be sold, leased, rented or occupied by any person or corporation other than yourself, it is incumbent that you advise them regarding the conditions and/or limitations of this grant.

VIOLATIONS OF THESE CONDITIONS

Violations of conditions required by this determination may constitute a misdemeanor or infraction under section 1.20.010 of the Glendale Municipal Code (GMC) and/or a violation of other local, State or Federal laws or regulations. Unless a specific penalty is provided, any person convicted of a misdemeanor shall be punished by a fine not to exceed one thousand dollars (\$1,000.00), or imprisonment for a term not to exceed six (6) months, or by both fine and imprisonment. Infractions are punishable by a fine not exceeding the sum of five hundred dollars (\$500.00) for each violation. Violations of conditions required by this determination may be grounds for a revocation.

REVOCATION

Section 30.64.020 – Revocation – The Community Development Department shall have continuing jurisdiction over variances, conditional use permits, administrative exceptions and wireless telecommunication facilities. To consider the revocation, the Director of

Community Development shall hold a public hearing after giving notice by the same procedure as for consideration of a wireless telecommunication facility at least 10 days notice by mail to the applicant or permittee.

NOTICE - SUBSEQUENT CONTACTS WITH THIS OFFICE

The Applicant is further advised that all subsequent contacts with this office regarding this determination must be with the Case Planner first and then, the Hearing Officer who acted on this case. This would include clarification, verification of condition compliance and plans or building permit applications, etc., and shall be accomplished by appointment only (in order to assure customer service with a minimum amount of waiting). You should advise any consultant representing you of this requirement as well.
