Moved by Planning Commissioner Chraghchian, and seconded by Planning Commissioner Astorian, that upon consideration of the proposed Development Agreement (DA) relating to the implementation of an Advertising Signage Overlay Zone (ASOZ), that the DA is consistent with the Glendale General Plan, the Town Center Specific Plan, and the Downtown Specific Plan (DSP) in that the DA implements revenue sharing for signs that are already permitted under the Glendale Municipal Code, provided for by the ASOZ designation and identified by the August, 2013 Zone Map Amendment and is therefore consistent with the DSP; and the General Plan land use designation for the Town Center District is DSP and thus the DA is consistent with the Land Use Element of the General Plan, and the Planning Commission hereby recommends that the City Council approve the ASOZ DA.
