RELEASE OF LIABILITY & INDEMNITY AGREEMENT

I, _____, acknowledge that I have voluntarily applied with the City of Glendale's Community Services and Parks Department ("the City") to participate in the competitive sport of adult league softball, from January 1, 2021 through February 28, 2022 (inclusive of all seasons and teams throughout this time period). The softball activities will take place at one or more of the City facilities listed below:

Glendale Sports Complex (2200 Fern Lane, Glendale);
Montrose Community Park (3529 Clifton Place, Glendale); or
Glorietta Park (2801 N. Verdugo Road, Glendale).

I understand and agree that I am using the City's facility, including any City-provided equipment, to practice, play, and compete in softball with other adults, in a competitive softball league. Playing softball in a competitive league has risks that include, but are not limited to: slipping and falling; colliding with other persons, objects, or the City's facility; being struck by a ball or bat; cold or hot weather conditions; insect or animal bites; sunburn; broken bones; concussion; physical injury to muscles, tendons, and body parts; cuts or scrapes; pain or soreness; fatigue or exhaustion; dehydration; nausea; or death.

I understand and acknowledge that while I am participating in the softball activities at the City's facility, I will be under adult supervision of the team manager. For the softball activities, I will wear my own protective body clothing or equipment, and I will bring and drink water. I agree to inspect the City's facility and any equipment, before using or operating them, to determine their suitability and fitness for the softball activities. I represent that I am: (1) in good physical condition and emotional health; (2) not suffering from any condition, disease, or disability that can hinder or endanger my participation in the softball activities; and (3) qualified to participate in the softball activities. **PLEASE INITIAL:** _____.

I REALIZE THAT SOFTBALL ACTIVITIES ARE PHYSICALLY DEMANDING, CAN BE DANGEROUS, AND HAVE A RISK OF SERIOUS INJURY OR DEATH. I AM FULLY AWARE THAT I AM VOLUNTARILY PARTICIPATING IN THE ACTIVITIES— AND VOLUNTARILY USING THE CITY'S FACILITY AND EQUIPMENT— WITH MY KNOWLEDGE OF THE INHERENT RISKS AND HAZARDS INVOLVED. I HEREBY AGREE TO ACCEPT ANY AND ALL RISKS OF INJURY, DEATH, OR PROPERTY DAMAGE. PLEASE INITIAL: _____.

AS LAWFUL CONSIDERATION for the City's permitting me to participate in the softball activities— and to use the City's facility and equipment— I HEREBY AGREE that I, my heirs, distributees, guardians, legal representatives, and assigns WILL NOT MAKE A CLAIM AGAINST, SUE, OR PROSECUTE the City, its officers, agents, or employees for injury, death, or damage arising out of the negligence, intentional, or other acts, howsoever caused, by the City or by any officer, agent, or employee of the City, as a result of my participating in the softball activities, and my using the City's facility and equipment.

In addition, I HEREBY RELEASE, DISCHARGE, AND AGREE TO "INDEMNIFY" (TO COMPENSATE AND TO DEFEND) the City, its officers, agents, and employees from and against ALL ACTIONS, CLAIMS, OR DEMANDS that I, my heirs, distributees, guardians, legal representatives, or assigns now have, or may later have from today, for injury, death, or damage arising out of my participating in the softball activities, and my using the City's facility and equipment.

I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT TO INDEMNIFY BETWEEN MYSELF AND THE CITY, AND I SIGN IT OF MY OWN FREE WILL. I UNDERSTAND THAT THIS AGREEMENT WILL REMAIN IN EFFECT AT ALL TIMES DURING THIS YEAR WHILE I PARTICIPATE IN THE SOFTBALL ACTIVITIES AT THE CITY'S FACILITY.
