* W9 is required in order to issue a check for the rebate. If the total amount of rebates received from City of Glendale exceeds \$599 in a calendar year, the amount might be reportable to the IRS.

PROGRAM TERMS & CONDITIONS

1. Applicant must either be a GWP customer with an active GWP residential electric account or reside in Glendale. If applicant is not a GWP residential electric account holder, two forms of documentation demonstrating residence at the account address is required.
2. Primary owner of the new electric bicycle must permanently reside at the residential electric service address listed on this application.
3. Application must be signed, dated, and contain all supporting documentation.
4. GWP is not responsible for items lost or destroyed in the mail or by email.
5. Applications must be submitted no later than six months from the date of purchase and are accepted on a first come, first served basis until program funds are depleted.
6. Rebates are issued in the form of a paper check from the City of Glendale within 2-3 weeks of application approval.
7. Rebates are limited to 1 per applicant. No limit on number per service address.
8. The rebate amount cannot exceed the purchase price.
9. Bicycles must meet [CA DMV handbook](#) requirements for electric bicycles. This includes having fully operable pedals and an electric motor of 750 watts or less. Scooters, mopeds, motorcycles, segways, and electric bicycle conversion kits are not eligible for this rebate.
10. Offer is valid on new products only. Used or resold electric bicycles are not eligible for rebates.
11. GWP will evaluate effectiveness of rebate and may adjust the amount if necessary, and as the budget allows.
12. This program may be modified or terminated without notice.
