RENOVATION/ DEMOLITION ACKNOWLEDGEMENT FORM

1. Rule 1403 Acknowledgement

South Coast AQMD Rule 1403 is applicable to any renovation* and/or demolition** activity, any clean-up of associated disturbance of asbestos containing materials, own/operate any asbestos storage facility, or own/operate any asbestos waste disposal site. As the site operator, you are subject to Rule 1403 requirements for the survey***, notification, asbestos removal procedures, the handling and the disposal of asbestos-containing materials (ACM). An inspector may visit your site any time before, during, and/or after renovation*/demolition**/completion. Inspectors verify compliance with asbestos removal procedures and confirm that the asbestos was removed prior to demolition or renovation.

- *Rule 1403 defines renovation as the altering of a facility or the removing or stripping of one or more facility components in any way.
- **Rule 1403 defines a demolition as the wrecking, or taking out, of any load-supporting structural member of a facility and related handling operations or the intentional burning of any facility.
- ***Rule 1403 (d)(1)(A) requires an asbestos survey report, regardless of the structure age, prior to demolition or alteration activity to determine and verify the absence or presence of asbestos.

Exemptions:

- Legal owner of the single unit family dwelling (house) who is a permanent resident of this house and is
 PERSONALLY performing this house renovation themselves (NOT employing a contractor or laborer, and not
 being helped by friends, family or anyone else) are exempt from all or part of Rule 1403. See Rule 1403 (j)(9).
- Renovation activities which involve less than 100 square feet of surface area of ACM are removed or stripped. See Rule 1403 (j)(1).
- The survey requirements shall not apply to renovation activities of residential single-unit dwellings in which less than 100 square feet of surface area of ACM are removed or stripped. See Rule 1403 (j)(10).

Note: <u>All demolitions require a Notification.</u> Notification Forms should be completed, signed, paid, and mailed by the contractor performing the asbestos removal and/or demolition project.

2. Owner's Declaration
